

## 2025 SCHOOL FEES & CHARGES INFORMATION

### ANNUAL SCHOOL FEES 2025

<b>Full Fee</b>	\$3200.00
<b>Lower Income Fee</b>	\$1920.00

#### **Full Payment Discount**

A 5% discount will apply to School Fees if they **are paid in full by 21<sup>st</sup> February 2025**.

#### **What is included?**

The fee above covers all tuition, levies and charges for each child's education.

Stationery including afterschool sports, extracurricular activities, excursions, camps, and uniforms are excluded and will be charged separately.

#### **Additional Charges**

Camps are conducted in Years 3 to Years 6 annually. Fees vary each year, and families are invoiced separately to school fee accounts.

An annual \$25.00 Music Administration Fee, per student, applies to all students who participate in Instrumental Tutor Lessons and is payable within 14 days of invoice.

Please note additional charges are not included in direct debit and credit card payment plans. If you require additional charges to be included into payment plans, please contact the Finance Office on 8251 9500.

#### **Lower Income Fee**

To be eligible for the lower income fee, you need to qualify as a low-income family. This is determined by your family's gross income and is a \$ value set by the State Government.

In 2024, your family's gross income needed to be below approximately \$70,994 for a family with one school-age child and the 2025 limits will be available in February. (The limit will vary depending on how many dependent children you have.)

Proof of income is required and applicants will need to apply via the [State Government's School Card scheme](#). Applications are normally available before the start of the School Year.

Our Finance team can help you if you have any questions about applying for the lower income fee.

### **PAYMENT OPTIONS**

#### **Payment Methods**

Payments can be made in full or by an approved payment plan that must be fully paid by 28<sup>th</sup> November. We encourage all families to set up weekly, fortnightly or monthly direct debit payments as our preferred method of payment.

Payment options include:

- Direct Debit – deductions from your bank account (forms available on the school website).
- BPAY – Biller Code 299404 and reference numbers are printed on invoices and statements.
- Credit Card – Visa or MasterCard (forms available on the school website).
- Cash or EFTPOS.
- QKR App – Instructions can be found on the SFX Website [St. Francis Xavier's Wynn Vale | School Fees](#) and Parent Handbook.
- EFT – BSB: 066 782 Account: 100 000369 (please use the BPAY reference number as your reference).

#### **Frequency of Payment**

You can choose to make your payments weekly, fortnightly, monthly or termly. All payment plans must start before **Friday 21<sup>st</sup> February 2025**.

If paying per term, fees are due and payable over Terms 1, 2 and 3 and payment is required by Week 5 of each term.

#### **Late Payment Charges**

St Francis Xavier's Regional Catholic School openly encourages regular communication between all parties. If families are unable to pay school fees prior to the due date, families must make contact with the School Finance Department. Failure to do so will result in a \$20.00 late payment fee applied to family accounts for each term's outstanding arrears.

### **ENROLMENT FEES**

#### **Enrolment Application Fee**

A (non-refundable) \$50 (GST incl.) Application Fee for all new student enrolments is payable when submitting an Enrolment Form.

#### **Acceptance Fee**

A (non-refundable) \$100.00 Acceptance Fee is payable upon return of your Enrolment Contract to secure a position at St Francis Xavier's Catholic School. **This amount is credited to your child's first term fees.**

**Split Family Accounts**

It is the legal responsibility of the signatories on the Enrolment Form to pay all school fees. Where possible, parents are asked to make their own arrangements regarding payment of accounts if they live at separate addresses. Should split accounts be required, contact will need to be made with our Finance Department to complete the applicable forms.

**Absence Due to Holidays**

Fees shall not be reduced for a student due to holidays (intrastate, interstate or overseas) during a school term.

**International Students**

Full Government funding plus tuition fees will be charged to students that hold a visa that does not qualify for government funding.

**Holding Fees**

Full Government funding plus tuition fees will be charged to hold a place for students while absent from the school for an extended period.

**Withdrawal of a Student**

One full term's notice of your intention to withdraw a student from the school is required in writing, to the Principal. Where this is not adhered to, the school reserves the right to charge a full term's school fees. Extraordinary circumstances will be considered.
